- I have completed a Dutchess Community College admissions application identifying that I am applying for the Nursing Program. (If not already a DCC student).

- I have attached the completed Nursing Eligibility Rubric and understand that Admission into the program is competitive based on points earned, GPA (minimum of at least 2.75) and TEAS scores.
- I have taken the TEAS (*Test of Essential Academic Skills*) within the 18 months and earned a score of 'Proficient' or higher. If the TEAS test was not taken at DCC, results must be sent to DCC from ATI, or be retrieved in person with an advisor.

The following are the various pathways for students to enter into the Nursing Program.

LPNs: Please indicate if you are interested in pursuing pathway #3.

Path 1a:

First time college students (non-transfer) that place into non-remedial courses (ENG 101, College Level Math, and BIO 131), and score at least Proficient on the TEAS exam can begin the Nursing Program. These students are full-time taking nursing courses along with their general education requirements. To qualify for this path, students must have met placement requirements and taken the TEAS exam prior to the March 1st deadline .

Path 1b:

Students transferring from other colleges/universities and DCC students who are changing their majors to pursue nursing must place into non-remedial courses if they have never taken college level writing, math, or anatomy and physiology. If the placement indicates non-remedial courses (ENG 101, College Level Math, and BIO 131), then the student is eligible to take the TEAS exam in which they need to have a score of at least Proficient. In addition, students must have a cumulative GPA of at least a 2.75 (if student is a transfer student the GPA from any previous colleges may be considered).

Once this criteria is complete students must apply by March 1st to be considered for the Nursing Program. Admission is competitive based on points (see rubric) and seat availability.

Path 2:

Students who do not place into all college level courses based on placement requirements (ENG 101, College Level Math, and BIO 131) must complete all non-nursing courses prior to applying to the Nursing Program as a General Studies major. These courses are ENG 101, ENG 102, BHS 103, HIS 103 or HIS 104 or GOV 121, PSY 111, PSY 203, BIO 131, and BIO 132. (BIO 132 may be in progress at the time of application) Students must have these courses completed and have an overall GPA of at least a 2.75. They must then score at least 'Proficient' on the TEAS exam. Once this criteria is complete students must apply by March 1st to be considered for the Nursing Program. Admission is competitive based on points (see rubric) and seat availability.

Path 3: Yes, I am interested in path #3: _____

LPNs are eligible for the NYS LPN to RN path. Students wishing to pursue this path must have a current LPN license. LPNs who have not taken college level math, English and Anatomy and Physiology must meet placement requirements. If placement indicates non-remedial courses (ENG 101, college level math, and BIO 131), and students score at least 'Proficient' on the TEAS they can begin the two year nursing program as a full-time student taking their nursing courses with their general education requirements. If they place into remedial courses, they must complete all coursework (ENG 101, ENG 102, BHS 103, HIS 103 or HIS 104 or GOV 121, PSY 111, PSY 203, BIO 131, and BIO 132), have at least a 2.75 GPA, and score 'Proficient' on the TEAS exam before applying to the program. (BIO 132 may be in progress at the time of application.) Once this criteria is complete students must apply by March 1st to be considered for the LPN to RN Nursing Program. Admission is competitive based on points (see rubric) and seat availability. The LPN to RN program is not accelerated. Once students begin their nursing courses they have four semesters of coursework to complete.
